I give praise to God for His carrying me through some discouraging times. Sometimes my urgency of seeing people set free causes me to be down when the process doesn't go as quickly as I desire. Just like I often share in the newsletters with you, I have to remind myself that "Christ is victor."

Short Report:

Having already addressed his personal and ancestral sin on his own and with others praying for him, Mr. HH, was not sure why he still felt troubled. He struggled with criticism and lust. A friend reassured him that it wasn't him, but the work of evil spirits. Then, he sensed God telling him as well that the issue was due to demons. For me, in lending a hand to someone, it is concerning that the person senses the demons as he did, but they had not responded when confronted before. Nonetheless, we took time to confront the evil spirits. I went through the normal list of ground rules that are given to the evil spirits. In the name of Jesus Christ, I cut them off from their reinforcements and support structures, whether demons above them or below them in rank, Satan worshipping covens, or other people to whom the spirits were connected. Then I bound them to the rank they held when they first arrived. I forbade them to switch from demon to demon who is answering my questions. Only the same spirit is to answer, unless I chose to address another. I forbade them to be violent, to embarrass anyone, to compromise our dignity or integrity. I forbade them to flee, and even ask for holy angels to bring them back if they had already fled. I forbade any confusing answers, grandstanding answers, or answers with profanity. They were to give clear, concise, and truthful answers. Finally, I forbade them to make any vows of silence, or declarations to be deaf or mute. They could hear my orders, which were standing, and were to be obeyed. All orders from anyone else on their side were cancelled. In some fashion, I share this with the spirits any time I start to confront them with a client. In this case,

when I ordered the spirit to attention, Mr. HH saw a picture of an eye in his mind. I asked him if it looked like the all-seeing eye that is often associate with Freemasonry. He affirmed that it did. The spirit didn't like the fact that we had identified him. Just to be sure, Mr. HH cancelled any inherited curses on him or his family for involvement in Freemasonry. The Freemason spirit had no more right to stay and was evicted. It should be noted as well that Freemason spirits are often involved in sexual sin as well, and likely was behind his struggle with lust. Two other spirits then were identified: Sledgehammer and Legalism/Law. They had no more right as well and were cast out. The Holy Spirit then ministered to Mr. HH, showing him that he was pure and clean. He left in peace.

Something to Consider:

- **Exodus 8:7**—But the magicians did the same things by their secret arts; they also made frogs come up out of the land.
- **2 Peter 2:1**—But there were also false prophets among the people, just as there will be false teachers among you. They will secretly introduce destructive heresies, even denying the sovereign Lord who bought them—bringing swift destruction on themselves.

The danger of secret societies, such as Freemasonry, is that it is false doctrine that teaches the worship of Satan instead of God. Like the arts of the Egyptian magicians, the meetings are done in secret. The truth of what one is joining is usually hidden. In actuality, the blood oath is a blood contract with Satan. The consequences then are that the person and his descendants are bound to Satan, unless they apply the blood of Jesus to the oath. Masonry rejects the Lord Jesus, but promotes the worship of a supreme being (in reality, Satan). So one can worship any god he desires. He may think in this he's worshiping God, but he's not at all. The consequences indeed are very destructive.

The case report above gave more details about the approach to confronting spirits. I thought it was fitting to give more details and not hide what is done, as that would be counter to how the forces of darkness work. In the process of confronting the spirits, they were exposed, no longer able to hide and afflict the man. Mr. HH didn't choose to be a Mason, but he was burdened by an ancestor's choice to do so. Praise God for His intervention for us through Christ on the cross. Because of God's love, the evil was exposed and Mr. HH could be set free!
